INDONESIAN CAT COUNCIL (ICC) BY LAWS

The validity period of Indonesian Cat Council (ICC) is limitless and in accordance with legal notarial deed of notarized Yus Hermawan, SH. M.Kn No: 72 Dated 20 March 2017, which located at Kom. Yos Soedarso No. B/3 Putussibau – West Kalimantan Indonesia and Ratification of legal entities from the Ministry of Law and Human rights No: AHU-0004992.AH.01.07 2017 dated 21 March 2017.

CHAPTER I MOTTO AND SYMBOLS

Article 1 Motto

Indonesian Cat Council (ICC) Motto is "Family spirit and togetherness".

Article 2 Logo



Indonesian Cat Council (ICC) symbols is in Silhouette shaped of cat body formed as abstract and rainbow colored of batik pattern, overlooking Tosca colored abstract ball with striped straight upward and laterally meaningful for diversity of cat breed, creates something beautiful symbolized by a Tosca globe there is a ribbon below with the inscription capital letters abbreviation "Indonesian Cat Council" means ICC dare reveal to the public that The Indonesian Cat Council purpose is pure and clean.

CHAPTER II RIGHTS, DUTIES AND STATUS OF MEMBER

Article 3 Member Rights

Each member has the equal rights in the doing of statutes and bylaws as well as the work program that has been set.

Article 4 Member Duties

- Regular members have obligation based on the Statutes of Organization and Bylaws and pay contribute for fee Rp. 250.000, - (two hundred and fifty thousand rupiah) every year each person.
- 2. Every cattery name of members have to be registered with the World Cat Federation (WCF.)
- 3. Breeders, who have provably registered their cattery name in another organization, are permitted to keep their name. Should the cattery name be elsewhere already taken, the country code must be added behind the name.
- 4. Only for member who are WCF registered catteries WCF pedigrees can be issued.
- 5. Attending Assembly and Meeting ,implementing the programs which is created before
- 6. Each member is obliged to obey with all the Statutes and Bylaws or other provisions.

CHAPTER IV CODE OF ETHICS/CONDUCT

- Article 9 All persons applying for membership, as outlined in The Indonesian Cat Council (ICC) Constitution, shall agree to be bound by this Code of Ethics relating to responsible cat ownership, including the maintaining, keeping, welfare, breeding, exhibiting, marketing, selling and disposing of cats to the effect of the terms and conditions set out hereunder.
- Article 10 Under the terms of this Code of Ethics, the word member(s) applies to any person/persons/groups that belong financially or in any manner to and Indonesian Cat Council (ICC)
- Article 11 Shall ensure that at all times, any or all cats or kittens under a member's control is/are properly housed, fed, watered, groomed, cared for and receive proper veterinary attention if and when required. Each kitten born has to be registered and it is not allowed to be placed without pedigree. The kitten's placement has to be documented by the contract. With this contract the breeder has to inform the new owner of the cat about its needs. The breeder shall assist the new owner with his help.
- Article 12 Shall agree to follow both Indonesian Cat Council (ICC) Constitution and the relevant local Council or Government Regulations in regard to the breeding and ownership of cats
- Article 13 Shall agree that at any time, if a pedigree or registration number is in doubt, that a cat/kitten may be examined for classification or verification of correct identification by a panel or no less than three WCF fully qualified Judges plus the Registrar.
- Article 14 Shall agree that any member of Shall agree that at any time, if a pedigree or registration number is in doubt, that a cat/kitten may be examined for classification or verification of correct identification by a panel or no less than three WCF fully qualified Judges plus the Registrar shall not knowingly allow any entire cats/kittens to roam at large without supervision
- **Article 15** Whilst it is recognized that the majority of kittens will be sold as pets, the aim of breeders should be to use breeding programs to improve the overall standard of their chosen breed.
- **Article 16** At all times the member shall retain the right of free trade to advertise directly and sell cats/kittens without misrepresenting them in any way.
- Article 17 Except in extenuating circumstances, cats/kittens should not be bred from under the Page 3 of 6

age of 12 months old and not more frequently than twice in any 12 month period

- Article 18 That all pedigree kittens bred by members shall be Litter Registered
- Article 19 Young kittens are not allowed to be separated from their mother and litter mates before the 12th week. When placed young kittens must be weaned, de-wormed and equipped with the necessary vaccinations. It is strongly recommended to identify the kittens by micro-chip
- Article 20 Members shall ensure that when selling any cat/kitten it shall have received at least one Triple vaccination, Rabies Vaccination and is accompanied by a current vaccination certificate, pedigree certificate, Medical Check Up Letter form Veterinarian. (form downloadable at www.icc-wcf.org) plus instructions regarding diet and housing requirements.
- Article 21 That the member selling the cat/kitten, fully explains to the new owner/s their responsibility for the care and welfare of the cat/kitten including dietary, protection, immunization, husbandry and housing requirements.
- Article 22 Members shall oppose and report all activities which involve cruelty to cats.
- **Article 22** All persons in attendance at any Indonesian Cat Council (ICC) function or licensed show are required to behavior in seemly manner, avoiding any form of conflict with exhibitors, officials, Judges or visiting public.
- Article 23 Member who violates this rule will be penalized and sanctions

CHAPTER V CAT SHOW

- Article 24 International cat show follows all the rules of the WCF
- Article 25 National and local cat show must be approved by WCF

CHAPTER VI REGISTRATION OF CATTERY NAME

Article 26BREEDERA breeder is a person who applies for pedigrees at his Indonesian Cat Council (ICC)for kittens born in his household (in a breeder community).

Article 27 KITTENS - LITTER

Each kitten born in the household (in a breeder community) must have a cattery name and a pedigree authorized by Indonesian Cat Council (ICC).

Article 28 CATTERY NAME

A cattery name is an artificial name, which is applied and registered at the WCF by Indonesian Cat Council (ICC) and which is consequently protected. Each cattery name has to be requested at the office in Essen by Indonesian Cat Council (ICC). 3 proposed cattery names (in the sequence of their priority) have to be requested through the breeder's (main) club. The full name (written and not abbreviated), the complete address, at least a phone number, email-address (when available) of the breeder have to be provided. The proposed cattery names will be checked, if similar cattery names are already registered. It is not permitted to propose any names of persons (because of the law of names' rights) – except the own name, no names of public offices, no names of copyrighted documents (romances, novels,work of literature, etc.) and no names of breeds. Breeders with a registered provably cattery name in another organization, who wish to join the WCF, are allowed to retain their cattery names. Should the name already be used elsewhere, the country code must be added behind the name. The office verifies the uniqueness of the cattery names only within the WCF.

Article 29 PROTECTION OF THE CATTERY NAME

A registered cattery name will be protected 20 years and cannot be issued once more. That is also valid, when the breeder quits the WCF. If an applicant is member of the WCF, the cattery name will be protected for a lifetime.

Article 30 TRANSFER OF A CATTERY NAME

A cattery name can be transferred by a breeder to another breeder by a written contract signed by both breeders, which must be forwarded to the WCF office by Indonesian Cat Council. When a breeder dies, the heir has to testify certified that he is the legal heir to take or transfer the cattery name.

Article 31 NAME OF THE CAT

In general the name of the cat consists of the first name and the cattery name. The entire name of the cat – first name and cattery name – may not be longer than 25 characters.

Article 32 POSITION OF THE CATTERY NAME

The cattery name can be before or after the first name of the cat. You must indicate the position, when you apply for a cattery name. Examples:

Maccurl's Mimi – cattery name before the first name of the cat Mimi Maccurl – cattery name after the first name of the cat Mimi of Maccurl – cattery name after the first name of the cat

Please note that you have to provide the prefix and suffix of the cattery name and do not use any abbreviations. Also not: v. Maccurl – correctly von Maccurl

Not: v.d. Waldhöhe – correctly von der Waldhöhe

Prefix and suffix count for the length of the entire name of the cat.

CHAPTER VII IMPROVEMENT

Article 33 Improvements of The Bylaws can be done by a special assembly and accountable decisión to next assembly.

CHAPTER VIII CLOSING

Article 34 Other things that have not been regulated in the Bylaws will be regulated through the assembly.
